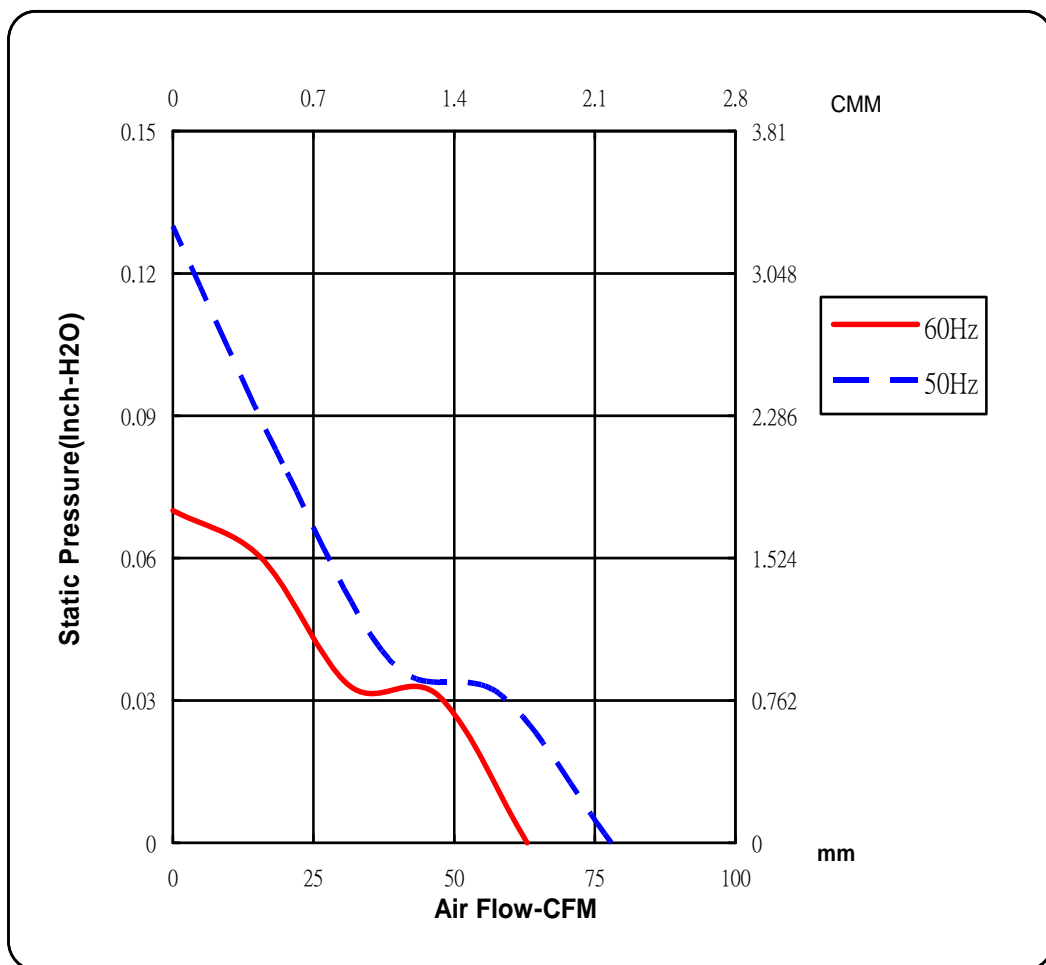

**PERFORMANCE CURVES**



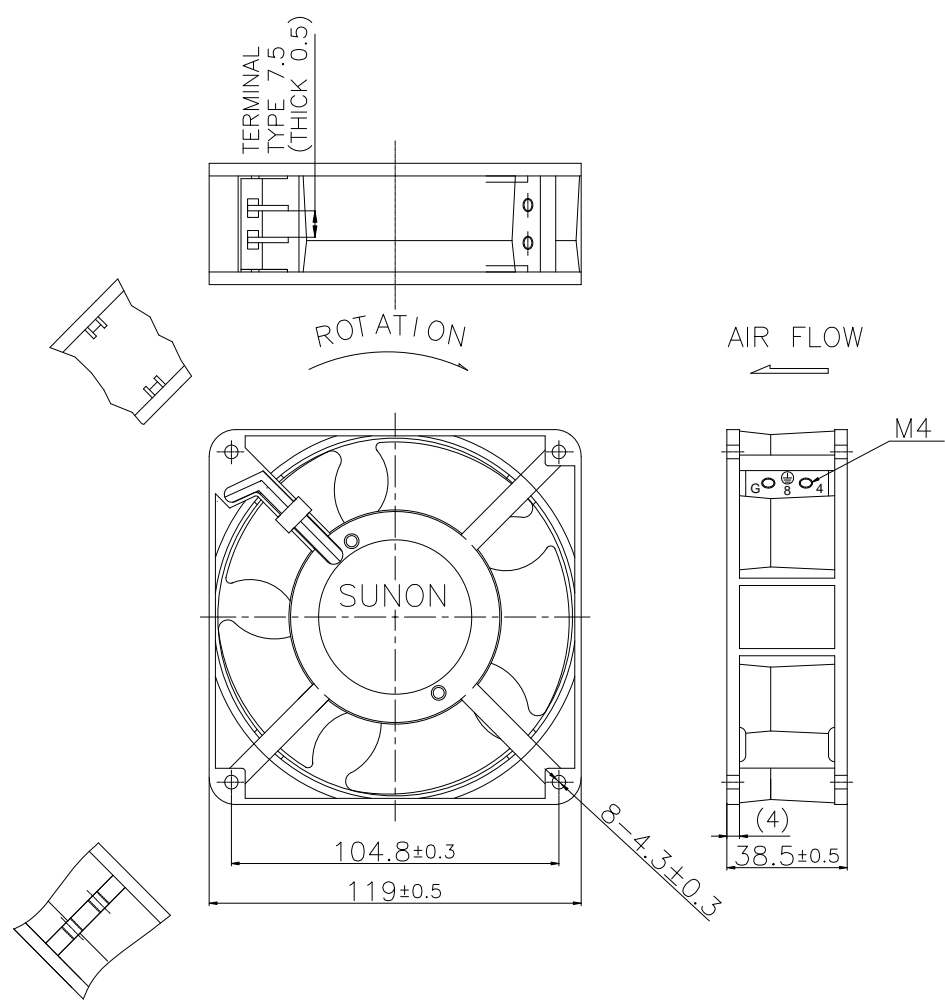
